1. Future Meetings(for endorsement): Resolution IRG 34.1

The following gives the IRG future meeting schedules:

2. CJK BMP CD Review (for information): Resolution IRG M34.2

A scheduled of one round of review is conducted for FDIS preparation is completed.

3. CJK_B Multi-column Code Charts Review (for information): Resolution: IRG 34.3

IRG will conduct two rounds of full reviews. 1st round of member review will be conducted between IRG Meeting No. 34 and No. 35 with 4 subdivisions. IRG review and discussion of 1st round will be conducted during IRG Meeting No. 35. Then the 2nd round of member review will be conducted between IRG Meeting No. 35 and IRG Meeting No. 36. It is the intention of IRG to complete the review at IRG No. 36.

4. Macao Supplementary Character Set Submission(for information): Resolution IRG 34.4

Due to the privacy issues, the format of the evidence for MSCS submission was discussed and agreed that Macao has to submit evidence for every character for inclusion. However, any particular to reveal personal information will be blocked.

5. CJK Extension E Work (for information): Resolution IRG 34.5

CJK Extension E collection is frozen in IRG 33. All additional request will be considered for extensions after CJK Extension E.

All members will review the D set of Extension E and submit report by Oct. 8, 2010. Members must have evidences submitted by Oct. 8, 2010 for discussion in IRG Meeting No. 35.

6. Old Hanzi Work (for information): Resolution IRG 34.6

The Old Hanzi Group has agreed to improve its record keeping procedure to record all deletions and unifications in all future work. A review of the Old Hanzi Principles and procedures will be conducted. The consolidated Old Hanzi Collection Version 2 will be produced and 1 round of review will be conducted by members for IRG discussion at IRG No. 35 in Macao.
