Disposition of Comments

National bodies that submitted comments are listed below. Where a national body has submitted a negative vote the indication (N) appears after its name in the list.

Canada (N)

General: Not accepted.

This draft Annex is a correct factual description of the procedure that was used when CJK ideographs were unified for ISO/IEC 10646 First Edition, and of the arrangement of those ideographs in that edition. The level of detail included is sufficient for the user community for which this International Standard is intended.

1. Not accepted. "Informative " means what it says.
2. Not accepted. The paragraph is a clear statement of fact.
3. Accepted. The "may" will be deleted.
4. Not accepted. The term is self-explanatory.
5. Accepted. S.2.4 will now read "To illustrate rules derived from a: to c:"
6. Not accepted. The statement is correct.
7. Not accepted. Clauses of S.2.4 give examples, not rules.
8. Not accepted. It is a correct illustration of what was done in preparing the First Edition.

Italy

Comment is applicable to DAM.7, but not to this DAM.8.

Japan (N)

1. Accepted
2. Accepted
3. Accepted in principle.
