- 1) China agrees to add 5 Yi radicals raised by Ireland (WG2 resolution M38.8), China proposes to add 2 more radicals in addition to those 5 radicals.

Attachment 2 - Japan

Japan agrees the proposal described in SC2 N3449. However, There is a draft AMD-1 as WG2 N2228. This draft is not complete, therefore, review process of the n2228 is needed.

Attachment 3 - Norway

We do not believe there should be a large architectonic change in 10646 at present. We also think that there may be needs in the future for space exceeding 21 bits (combination of glyphs and coded characters etc). We want to keep the 31 bit code space opportunity.
