## *Technical comment*

T1. **Tables 202 and 203.** Change "VARIATION SELECTORS" to "VARIATION SELECTORS SUPPLEMENT" in the block name as per the item at **Page 382, Annex A.1** on page 1. (The block name "VARIATION SELECTORS" is already in use for the block at U+FE00.)

## *Editorial comments*

E1. **Page 382, Annex A.1.** Change "AEGAN" to "AEGEAN".

E2. **Page 382, Annex A.2.** Change "AEGAN" to "AEGEAN".

E3. **2. New tables.** Change "Lineam B Ideograms" to "Linear B Ideograms".

E4. **2. New tables.** Change Ugaratic" to "Ugaritic".

E5. **Table 172 - Row 104: Osmanya.** The font is rather rough and should be improved.

E6. **Table 202 - Row E01: Variation Selectors Supplement.** The identifying number should be added to all of the glyphs here.
