"The proposed registration should be ENHANCED with identifying each code position with UCS short identifiers (mapping to UCS code points).. as provided for AS AN OPTION in the latest revised ISO/IEC 2375 procedures.

This the only way SC2 can ensure consistent interpretation of these code points in open interchange .. since the ideographs have no NAMES as such.

The proposer of the registration should be requested to provide such a mapping to the registrar following the guidelines in ISO/IEC 2375."
