Resolution 1 – Re-Appointment of JTC 1 Chairman

JTC 1 appoints Mr. Scott Jameson for a second three-year term of office as JTC 1 Chairman, subject to approval by the ISO TMB and IEC SMB.

Resolution 2 – Administration of SC 36, Information technology for Learning, Education and Training

JTC 1 appreciates and accepts the offer of the National Body of the United Kingdom (BSI) contained in document JTC 1 N 7943 to assume the Secretariat of SC 36. JTC 1 is looking forward to working with the National Body of the United Kingdom in this new role.

JTC 1 notes that the National Bodies of Australia and Korea also expressed their desire to serve as Secretariat for SC 36. JTC 1 thanks both Australia and Korea for their interest and also for their willingness to negotiate and agree to the appointment of the UK as the Secretariat.

Finally, JTC 1 expresses its appreciation to the National Body of the United States (ANSI) for its support of the administration of the SC 36 Secretariat.

Resolution 11 - Reconstitution of the Study Group on Web Services

JTC 1 reconstitutes the Study Group on Web Services to:

- Continue work assigned in its Terms of Reference (JTC 1 N 7588 Annex B)
- Implement recommendations from its previous meetings
- Coordinate with Fast Track and PAS Submitters regarding web services.
- Produce an inventory of web services activities as a top priority item.
- Consider future activities for action

The Study Group will produce a report, with a summary of actions that have been initiated during its mandate and any remaining action items, for presentation at the JTC 1 2006 Plenary meeting in South Africa.

Resolution 12 – Appreciation to SC Chairmen and Secretaries and Expectation of SC Chairmen

JTC 1 sincerely thanks the SC Chairmen and Secretaries who took the time and effort to be present for this JTC 1 plenary and for providing such interesting presentations. JTC 1 reminds those SC Chairs that did not attend this meeting that the National Bodies get great value out of the SC Chairs’ participation in the plenary and expects them to participate directly in the future.

JTC 1 instructs the JTC 1 Special Working Group on Directives to ensure that the JTC 1 Directives reflect this expectation of SC Chairmen’s participation in JTC 1 Plenary meetings.

Resolution 13 - Ad Hoc Group on IT Vocabulary

JTC1 recognizes that the Canadian proposal contained in document JTC 1 N7862 offers a mechanism to support the updating of ISO/IEC 2382. JTC1 further recognizes that although this project has been officially approved by National Bodies (via default letter ballot), there is still uncertainty about this project. Therefore, in order to resolve this matter, JTC1:

- Reconstitutes the IT Vocabulary Ad Hoc Group through the next JTC 1 Plenary meeting in November 2006 in South Africa.
- Asks Canada to begin implementation of the Vocabulary mechanism by convening a first meeting of the IT Vocabulary Ad Hoc Group tentatively scheduled for February or March 2006.
- This first meeting will: 1) address all issues raised by SCs or National Bodies, 2) prepare an MOU for signature by ISO, IEC and Canada's Translation Bureau (re: Maintenance Agency role & responsibilities, terms for access, copyright arrangements, breach of contract terms, termination of arrangement), 3) prepare a clear statement of role and responsibilities of SCs and of the Translation Bureau and 4) develop a recommendation for JTC 1 regarding the maintenance of the standard, the change process for new terms and its formal publication.
- Instructs its SCs to nominate a representative to the Ad Hoc Group on IT Vocabulary (nominations should be forwarded to the JTC1 Secretariat by 15 January 2006).
- Strongly recommends that all SCs be represented at this first meeting.
- Invites an expert from IEC Central Office involved with IEC's database of terms and vocabulary to this first meeting.
- Instructs the Convenor to prepare an implementation plan, in co-operation with SC representatives.
- Instructs the Ad Hoc Group to address the Vocabulary Registry issue at this first meeting.
- Instructs the Ad Hoc Convenor to report to JTC1 on the project implementation status by 15 June 2006 and at the November 2006 JTC1 Plenary meeting in South Africa.

Note 1: It is understood that the product (Termium) being offered by Canada to support the updating mechanism will be free of charge. It is also understood that the resulting single part standard (ISO/IEC 2382, and possibly others) will be free of charge to JTC1 and its SCs for standardization purposes.

Note 2: It is also understood that the proposed mechanism can be used by SCs to support SC-developed TRs on Vocabulary.

Resolution 14 – Alignment of the JTC 1 Directives with the ISO/IEC Directives

JTC 1 reaffirms its desire and intent to align its Directives as far as possible with the ISO/IEC Directives and to produce a reduced set of JTC 1 specific procedures in the form of a JTC 1 Supplement to the ISO/IEC Directives.

JTC 1 notes that such alignment is compatible with JTC 1's goal to retain a web-based set of consolidated JTC 1 Directives, including both the common ISO/IEC Directives and the JTC1 Supplement, on the JTC 1 web site, for easy access and use by JTC 1 participants.

JTC 1 further notes that this is a multi-year project given the recent publication of the new ISO/IEC Directives as well as the JTC 1 Directives 5th edition.

Resolution 15 – Establishment of a JTC 1 Special Working Group on the Directives (SWG-Directives)

In accordance with Recommendation 5 of the 14-15 June 2005 meeting of the JTC 1 Ad Hoc on Directives (JTC 1 N 7849), JTC 1 establishes a JTC 1 Special Working Group on the Directives. The Terms of Reference for this Special Working Group are as follows:

- The SWG-Directives operates under the direction of JTC 1 to maintain the JTC 1 Directives and implement changes to the JTC 1 Directives agreed by JTC 1. The SWG-Directives shall monitor the implementation of existing procedures, evaluating their effectiveness and making proposals for changes where found necessary.
- The SWG-Directives shall cooperate with ISO and IEC in the development of detailed harmonized procedures.
- Membership in the SWG-Directives is open to all P-members of JTC 1. O-members of JTC 1, Category A Liaison members of JTC 1, and SCs may also participate in the SWG-Directives
- The SWG-Directives is empowered to issue 60 day JTC 1 Letter Ballots if necessary.

The SWG-Directives will be convened by the JTC 1 Chairman, and administered by the JTC 1 Secretariat. The JTC 1 Secretariat will serve as Project Editor for changes to the Directives text.

JTC 1 instructs its Secretariat to issue a call to National Bodies for participation in the SWG-Directives.

The first meeting of the SWG-Directives is scheduled for 8-10 March 2006 in Zurich, Switzerland. JTC 1 welcomes the offer of Canada to host a subsequent meeting of the SWG-Directives, tentatively the week of 24 July 2006.

Resolution 16 – Revision of Annex N to the JTC 1 Directives, Edition 5

JTC 1 approves document **JTC 1 N Banff 001A, Banff 001B and Banff 001C** as a replacement for the current Annex N, *The Normative Referencing of Specifications other than International Standards in JTC 1 International Standards - Guidelines for JTC 1 SCs*, of the JTC 1 Directives. JTC 1 instructs its Secretariat to implement this change in the JTC 1 Directives Edition 5 (.doc, .pdf and .html versions) as soon as possible and to advise JTC 1 National Bodies and Subcommittees when the change has been implemented.

With the approval of the revised Annex N, JTC 1 encourages National Bodies and Subcommittees to collaborate on rapidly progressing a first set of Approved RS Originator Organization (AROs) by providing the information required by the new ARO template form for those organizations which have specifications which many SCs have referenced. JTC 1 acknowledges the offers of PAS Mentors to assist the SCs in providing the ARO templates for the following organizations:

- IETF – (SC 36 to prepare template)
- IEEE – (SC 7 to prepare template)
- W3C – (SC 6 to prepare template)
- OASIS – (JTC 1 to prepare template)
- SMPTE – (SC 29 to prepare template)
- Unicode – (SC 2 to prepare template)

Resolution 17 – Revision of Clause 4.6 and Annex H to the JTC 1 Directives, Edition 5

JTC 1 approves the changes to clause 4.6, *Responsibility of Keeping Records*, and to Annex H of the JTC 1 Directives as specified in document **JTC 1 N Banff 002**. JTC 1 instructs its Secretariat to implement these changes in the JTC 1 Directives Edition 5 (.doc, .pdf and .html versions) as soon as possible and to advise JTC 1 National Bodies and Subcommittees when the change has been implemented.

JTC 1 notes that this change in requirements may be difficult if not impossible for SCs to implement with respect to currently published standards. Therefore, the new requirements apply to all new and existing projects and will apply to published standards at the 5 year review process but do not exclude documents related to past projects where available.

Resolution 18 – voided

Resolution 19 – Trial of Enhanced Use of Teleconferencing

JTC 1 encourages the utilization of the provisions of clause 7.11 of the JTC 1 Directives with respect to teleconferencing. To facilitate the use of this tool, JTC 1 extends the provisions of clause 7.11 as follows until the 2007 JTC 1 Plenary meeting:

- The use of teleconferencing is permitted for any subgroup of JTC 1 and its SCs.
- The restriction that an agreement on the use of teleconferencing must be unanimous is removed. Agreement on the use of teleconferencing shall be made by consensus of the group.
- The meeting organizer and host, in conjunction with the Chairman/Convener, are permitted to decide (with the consent condition described above) if a teleconference is appropriate for a meeting.
- All meeting materials must be accessible to all participants, and all meeting resolutions must be electronically distributed (via email or on a common website) before the meeting concludes.
- When considering the use of teleconferencing to support a meeting, meeting organisers should consider in advance the potential advantage to all participants. Additional consideration should be given to the impact of the timing of teleconference sessions for participants in different time zones, to those National Bodies which would not otherwise be able to attend the meeting and to the flow of the agenda in order to bring together local attendees and remote participants.

JTC 1 SCs are asked to inform JTC 1 of their experiences with the use of teleconferencing no later than the 2007 JTC 1 Plenary meeting.

Resolution 20 – Items for Consideration by the JTC 1 Special Working Group on Directives

JTC 1 forwards the following documents to the JTC 1 Special Working Group on Directives for consideration:

JTC 1 N 7986 Request from Japan During the Harmonization Process Between the JTC 1 Directives and the ISO/IEC Directives

Resolution 21 – JTC 1 Use of the Patent Statement and Licensing Declaration

JTC 1 approves document JTC 1 N 7991, Patent Statement and Licensing Declaration, for immediate use by JTC 1 Subcommittees. JTC 1 recommends that to the greatest extent possible, all declarations should be submitted using this form.

As explicit in N 7991, all forms are to be submitted directly to ISO and IEC Central Offices. JTC 1 requests that ITTF notify the appropriate Subcommittee that such a declaration has been received. This notification is an interim action pending full implementation of the patent database.

Resolution 22 – Monitoring of the World Standards Cooperation (WSC) Activity on Intellectual Property Rights (IPR)

JTC 1 instructs the JTC 1 Special Working Group on Directives to monitor the WSC activity on IPR and to make recommendations to JTC 1 on any required changes to the Directives based on the results of the WSC activity.

Resolution 23 – JTC 1 Support for the World Standards Cooperation (WSC) Activity Related to Intellectual Property Rights (IPR) Policies and Patent Database

JTC 1 welcomes and supports the work of the WSC to harmonize IPR policies, prepare a common patent declaration form and develop a common patent database across ISO, IEC and ITU.

Resolution 24 – JTC 1 Comments on the Patent Database

JTC 1 supports the comments contained in documents JTC 1 N 7968 concerning improvements to the patent database and encourages ITTF to take these comments into account in its continued development of the database.

JTC 1 supports the objective of centralizing patent information in a single database of ISO, IEC and ITU. The database should contain all information provided on the Patent Statement and Licensing form. JTC 1 encourages National Bodies and Subcommittees to provide feedback to ITTF on the usability of the newly released database.

JTC 1 Subcommittees are not authorized to create their own individual patent databases.

Resolution 25 – Request for JTC 1 Participation on ISO/IEC Strategic Advisory Group on Security

JTC 1 notes with great interest the report of the ISO Advisory Group on Security contained in document JTC 1 N 7869. JTC 1 further notes that an ISO/IEC Strategic Advisory Group on Security (SAG) has now been established to carry out the work identified in N 7869 and calls the group's attention to the fact that the work of SC 7 on Software Assurance and SC 22 on Programming Languages is also relevant.

JTC 1 seeks membership on the SAG and requests the ISO TMB, with the concurrence of the IEC SMB, to allow JTC 1 participation on the SAG. JTC 1 nominates its SC 27 Chairman, Dr. Fumy, to represent JTC 1's views on the SAG.

Resolution 26 – Request to JTC 1 Subcommittees Related to the Report of the ISO AG on Security

Noting the report of the ISO Advisory Group on Security contained in document JTC 1 N 7869 and ISO TMB's endorsement of the recommendations contained therein, JTC 1 calls the attention of SC 17, SC 27 and SC 37 to Recommendation 11 on Personal Identification. JTC 1 instructs SC 17, SC 27 and SC 37 to provide a report no later than the 2006 JTC 1 Plenary meeting that responds to the items raised in N 7869 on the topic of personal identification.

JTC 1 calls the attention of SC 27 to Recommendation 12 on Cybersecurity and instructs SC 27 to provide a response to Recommendation 12 no later than the November 2006 JTC 1 Plenary meeting.

Finally, JTC 1 calls the attention of SC 17, SC 27, SC 31 and SC 37 to Recommendation 15 on Transportation Systems and notes that SC 17, SC 27, SC 31 and SC 37 should perhaps consider the establishment of liaison with TC 204 to ensure that the requirements for identity and security in general are being addressed.

Resolution 27 – Request to ITU-T for JTC 1 Participation on ITU-T Coordination Activities

JTC 1 notes with great interest the report of the JTC 1/ITU-T Liaison Officer on recent developments within the ITU-T. Based on this report, JTC 1 instructs its Secretariat to apply to the ITU-T for membership on the following Coordination Activities:

- **Home Networking** (JTC 1 nominates the SC 25 Chairman as the initial JTC 1 contact for this Joint Coordination Activity)
- **RFIDs** (JTC 1 nominates the SC 31 Chairman as the initial JTC 1 contact for the correspondence group and follow up activities)
- **Next Generation Networks Global Standards Initiative and Next Generation Network Joint Coordination Activities** (JTC 1 nominates the SC 6 Chairman as the initial JTC 1 contact for both groups)

Resolution 28 - JTC 1 Representative to the ISO Steering Committee on Image Technology

JTC 1 authorizes the following delegation to represent JTC 1 at the ISO Steering Committee on Image Technology meetings until the 2006 JTC 1 Plenary meeting in South Africa and instructs them to coordinate the submission of a written report for consideration at the South Africa Plenary.

Resolution 30 - Timing of Contributions for the November 2006 JTC 1 Plenary Meeting in South Africa

JTC 1 establishes the following deadlines for contributions for the November 2006 plenary meeting in South Africa:

Documents for the South Africa Plenary, particularly those raising new issues/new agenda items or those for which a final agreement at the meeting is desired, must be delivered to the Secretariat no later than **6 October 2006** for posting on the JTC 1 web server. Documents received at the Secretariat's office after **6 October 2006** will be returned to the submitter and will not be considered.

The following exceptions are permitted:

Comments on posted documents provided they are received at the Secretariat's office in a form suitable for immediate posting, not later than **23 October 2006**.

A proposed document revision from a project editor, which incorporates comments received prior to the meeting and which is intended to be developed further at the meeting, provided they are received at the Secretariat's office in a form suitable for immediate posting, not later than **23 October 2006**.

The final agenda for adoption and use at the South Africa Plenary will be posted to the JTC 1 web site on **27 October 2006**.

For contributions submitted via email, the JTC 1 Secretariat will provide a mechanism by which the submitter will be notified that the contribution has been received at the Secretariat's office.

Nevertheless, ultimately the submitter is obligated to ensure receipt by:
