It is proposed to include into the next possible amendment for ISO/IEC 10646 a new character collection:

**Character Collection 284: MIS-1 (Multilingual International Subset-1)**

Add to the list in A.1 "Collections of coded graphic characters" the following entry after the entry #283:

284 MIS-1 see A.4.4 \*

Add the following note to the end of A.4 (before A.4.1):

NOTE – The acronym MIS indicates Multilingual International Subset.

Add a new subclause A.4.4 (after A.4.3):

A.4.4 284 MIS-1 is specified by the following code positions and ranges thereof:

The proposed character collection contains all characters which can be input on a keyboard by means of the current revision of ISO/IEC 9995-3 "Information Technology – Keyboard layouts for text and office systems – Part 3: Complementary layouts of the alphanumeric zone of the alphanumeric section". This standard edition is currently a FDIS (by resolution 2009:34 of ISO/IEC JTC1/SC35, Saskatoon 2009-08-26) and will probably be published as ISO/IEC 9995-3:2010 .

The prior edition of ISO/IEC 9995-3 referred to the character collection 281 "MES-1", which exactly represented the set which could be input by means of that standard (when augmented by the Euro sign). The current revision was extended to an international (rather than European) scope. Thus, it is proposed here to include the set which can be input by its means, reflecting the extended scope in its name.

By addition of the proposed character collection, the relation between ISO/IEC 10646 and ISO/IEC 9995-3 is maintained. (In fact, the table shown above is identical to the one presented in Annex A of the revised edition of the latter.)
