Unicode Character Properties

Sorting

These characters could be sorted immediately after:

023B;LATIN CAPITAL LETTER C WITH STROKE

023C;LATIN SMALL LETTER C WITH STROKE

Confusables

These characters could potentially be confused with U+0404 CYRILLIC CAPITAL LETTER UKRAINIAN IE and U+0454 CYRILLIC SMALL LETTER UKRAINIAN IE.

Usage

Neither of these characters is widely used. LATIN CAPITAL LETTER C WITH BAR was used in Webster's 1868 dictionary (figure 5). It is also part of the STIX project which was developed "mainly in support of an attempt to gain acceptance into Unicode of additional symbols used in mathematical and technical publishing." It is in the STIXNonUnicode font (http://www.stixfonts.org/) at Private Use Area codepoint U+E0A1. The *Elsevier Science Grid in Unicode* includes the glyph in "Grid B: Symbols" (see figure 6). The Elsevier document also includes a chart listing the position in the grid, the Unicode codepoint, HTML entities and a description of the symbol. This character is listed in the chart without a Unicode mapping and with the description of "Cambrian (era)" (see figure 7). It also appears as a symbol for the Cambrian period in the FGDC *Digital Cartographic Standard for Geologic Map Symbolization* (see figure 9). The example in figure 8 used U+0404 CYRILLIC CAPITAL LETTER UKRAINIAN IE to represent this symbol. It could be encoded as a letterlike symbol (CAMBRIAN SYMBOL). However,

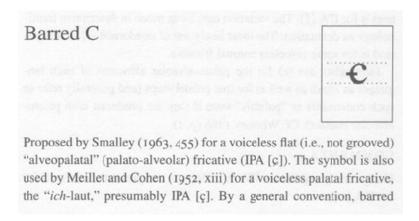


Figure 1. LATIN SMALL LETTER C WITH BAR (Pullum, 1996, p. 28)

since Pullum and Ladusaw cite use of a LATIN SMALL LETTER C WITH BAR in relation to phonetic transcriptions (see figures 1–3), which was also used in McGuffey's 1853 Reader (see figure 4), we believe a case pair should be encoded. In addition, the case pair was apparently used in a Latin orthography for the Nanai [ISO 639-3 gld] language for some years until about 1930 (see figure 10). Examples of usage are in the Figures section.

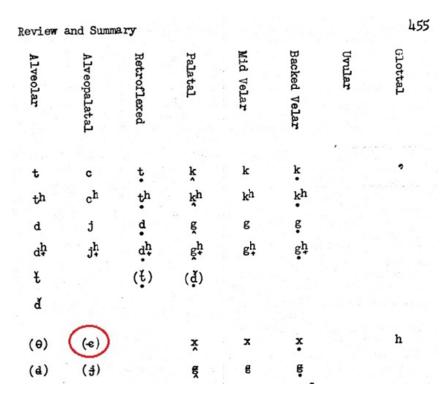


Figure 2. LATIN SMALL LETTER C WITH BAR (Smalley, 1963, p. 455)

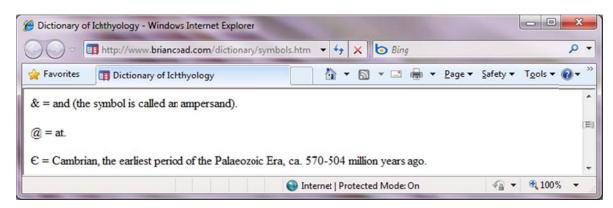
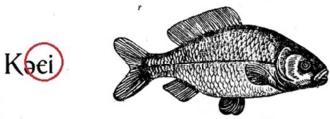


Figure 8. LATIN CAPITAL LETTER C WITH BAR (Coad, 2010).
