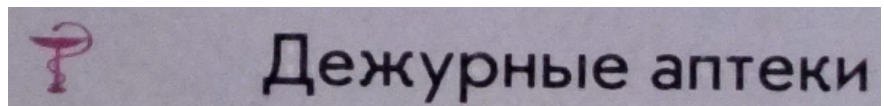
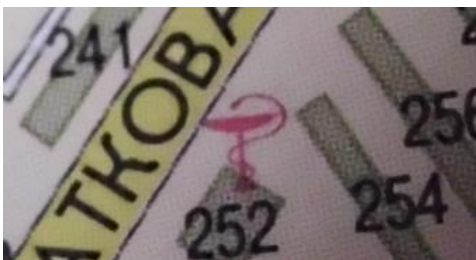
## Background

Bowl of Hygieia is a widely recognized symbol which is used to denote something related to pharmacy.<sup>[1]</sup> Hygieia is ancient Greek goddess of health and daughter of Asclepius (Aesculapius), god of medicine. Asclepius has his own symbol, rod of Asclepius (U+2695 STAFF OF AESCULAPIUS), which is used to denote something related to medicine in general.<sup>[5]</sup> The two symbols are closely related, both feature snakes. Staff of Asclepius is encoded in Unicode, bowl of Hygieia is not.

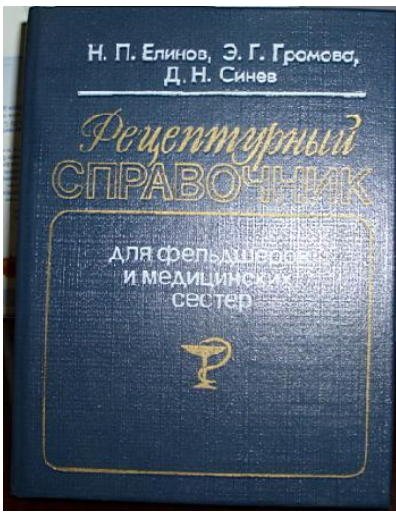
